Directions for Use

- Make sure there is no one left in the vehicle after the spray is opened!
- Shake before use.
- Turn on the air conditioner.
- Set the temperature setting to cold. •
- Run the air conditioner in the vehicle to circulation mode. •
- Set the ventilation system to maximum.
- Place the can on the right front seat base of the vehicle and turn on the spray head. •
- Turn off all electrical devices during application. Get out of the vehicle. •
- Keep the vehicle doors and windows closed for 20 minutes.
- When the tube is empty, let the air conditioner run for another 5 minutes and circulate thoroughly in • the vehicle.
- Ventilate the vehicle after the process is completed

*Applied only as a preventive measure at regular intervals (twice a year) in odorless air conditioner systems and vehicle interiors.

Remark & Restrictions

- Keep the packaging closed.
- Do not use for cleaning hands, body, face and food. •
- Avoid contact with eyes, wash immediately with plenty of water and seek medical help.
- In case of contact with skin, wash with plenty of water. •
- DO NOT BURN. •
- DO NOT expose to excessive heat above 50°C. •
- Keep away from sources of ignition and do not smoke. •
- Do not spray on a flame or an incandescent object.
