Shelf life:

12 months in unopened packaging in a cool and dry storage place at temperatures between +41° F and +77°F.

Remarks:

- Do not use on natural stones like marble, granite due to possibility of staining.
- Not recommended for use on PC and PMMA because it can cause crazing (stress cracking) on these materials.
